PLEASE TAKE NOTICE that the Mineral Point School District Board will hold a hearing on the above-named pupil's possible expulsion from the Mineral Point School District. If the pupil is expelled, the Board will determine the length of the expulsion period which may extend at a maximum to the pupil's 21<sup>st</sup> birthday.

- \_\_\_\_\_ the pupil knowingly conveyed or caused to be conveyed any threat or false information concerning an attempt or alleged attempt being made or to be made to destroy any school property by means of explosives OR
- \_\_\_\_\_ the pupil engaged in conduct while at school or while under the supervision of a school authority engaged in conduct which endangered the property, health or safety of others OR
- \_\_\_\_\_ the pupil while not at school or while not under the supervision of a school authority, engaged in conduct which endangered the property, health or safety of others at school or under the supervision of a school authority or endangered the property, health or safety of any employee or School Board member of the school district in which the student is enrolled.
- \_\_\_\_\_ the pupil is at least 16 years old and repeatedly engaged in conduct while at school or while under the supervision of a school authority that disrupted the ability of school authorities to maintain order or an educational atmosphere at school or at an activity supervised by a school authority and that such conduct does not constitute grounds for expulsion under the above.
- \_\_\_\_\_ the pupil, while at school or while under the supervision of a school authority, possessed a firearm as defined by federal law.

For these reasons the school administration believes the interest of the school demands the pupil's expulsion.

PLEASE TAKE FURTHER NOTICE, if the misconduct cited about is proved, in considering whether to expel the pupil, and if so for what period of time, the Board may also consider the pupil's complete disciplinary and academic records. These pupil records are available for your review as outlined in s.118.125, Wisconsin Statutes.

The administration intends to present witnesses at the hearing with knowledge of the incident(s) described above. The pupil and parent(s) each may be represented at the hearing by an attorney and the parties shall have the right to cross examine witnesses and to present such evidence and witnesses as deemed appropriate.
