










GROWTH

This priority area measures year-to-year student progress on statewide tests. It uses a value-added model that seeks to control for circumstances beyond the influence of educators. A high value-added score means that on average students in the district are progressing more quickly than other, similar students. Priority Area Score






English Language Arts Score: 69.8




TARGET GROUP OUTCOMES

Priority Area Score








Value-added scores converted onto a 0-100 growth scale.


