

# TICKET INFORMATION

## Doors Open

- Doors will open approximately 45 minutes prior to the start of each session.
- All spectators and any of the items they are carrying are subject to search. Review the list of illegal items on page 16 and share this list with fans attending the State Tournament.
- Spectators attempting to enter the Resch Center carrying prohibited item(s) will have them confiscated or be told to return the item(s) to their vehicle.

## Tickets for First Game

- Cheerleaders, band members, faculty, spirit groups, bus drivers, etc., must all have tickets to gain entry into the Resch Center. Only the 22 members of your team party will be allowed free admission to the tournament.
- Any unsold tickets must be returned to the Resch Center Ticket Office. **Schools will not be required to bring a check/cash to the Resch Center to pay for their tickets. All schools will be invoiced following the tournament for tickets sold.** Please return unsold tickets as quickly as possible upon your arrival in Green Bay. Following are the times that you must have any unsold tickets back to the Resch Center:
  - Divisions 3 and 4 - Thursday, 9 a.m.
  - Division 5 - Thursday, 5 p.m.
  - Division 2 - Friday, 9 a.m.
  - Division 1 - Friday, 12 p.m.
- The Resch Center Ticket office hours will be 11 a.m. to 5 p.m. on Monday, Tuesday, and Wednesday of the tournament week. The sale or resale of WIAA State Basketball tickets on Resch Center property by unauthorized persons is prohibited.
- Tournament tickets previously purchased by a school during the regular ticket sale period can be refunded or returned for credit provided the ticket(s) are a complete season set.
- Children under the age of two may be admitted at no charge. The child will not receive a ticket, but will be expected to sit in the lap of a parent or guardian during the entire session.

## Access for Individuals with Disabilities

- There are ADA seating locations scattered throughout the Resch Center ADA Level. All wheelchairs must be positioned in the wheelchair and wheelchair companion seating areas. A student fan in a wheelchair will not be allowed to sit in their student sections or on the floor of the Resch Center.
- Individuals needing these special seating locations must go to the Resch Center Ticket Office to purchase and/or exchange previously purchased tickets for these areas.
- Seating in the ADA area will only be allowed with a corresponding assigned ticket.
- There are public restrooms, concession stands, and drinking fountains on the Concourse Level of the Resch Center which are ADA compliant.

## Tickets for Thursday & Friday Winners

- A form is provided in "THE BOX" for you to identify how many tickets you'd like reserved for your band, cheerleaders, parents of players. Please complete that form and return it to the Resch Center Ticket Office upon your arrival at the Resch Center.
- **Tickets for Thursday and Friday game winners will be sold through the ticket windows immediately following each game.**
- Tickets for the school band will be prepackaged upon request. Please communicate your desire for this service upon returning any unsold tickets. Please know how many tickets you will need. Use the form provided in "The Box" to let us know how many tickets you will need pulled for your band, cheerleaders, parents, etc.
- Schools will not have the opportunity to take tickets back to their communities to sell. **ALL tickets will be either sold at the Resch Center ticket office or available online at TicketStarOnline.com.**

Dear Guests:

Welcome to Ashwaubenon! We hope that you enjoy your stay in the Village. In order to ensure that all of our visitors have a safe and enjoyable stay, we would like to make you aware of the following:

Ashwaubenon has a number of Village Ordinances dealing with unacceptable public behavior. These specific ordinances include noise- and alcohol-related offenses. Any adult, 17 and older, found to be violating these ordinances may receive a citation. Below is a list of several Village Ordinances, along with their deposit amounts. Adults who are chaperoning groups of juveniles will want to pay special attention to the curfew and procuring alcohol ordinances. Adults who do not have proper identification or are from out of state will be arrested and taken to the Brown County Jail to post bond for any ordinance violations.

Disorderly Conduct	\$439.00
Damage to Property (Including Hotel Property)	\$313.00
Unreasonable Noise (Including TV, Radio, etc.)	\$155.50
Procuring/Furnishing Alcohol to Underage Person	\$376.00
Underage Person Possessing/Consuming Alcohol (off licensed premises)	\$376.00
Underage Person Possessing/Consuming Alcohol (on licensed premises)	\$376.00
Social Hosting Violation	\$313.00
Open Alcohol Container on Street	\$187.00
Permitting Juvenile to Violate Curfew	\$124.00
Violating Curfew (under 17 years of age)	\$ 92.50

There are similar ordinances for juveniles, persons age 16 and under. The deposit amounts are slightly different. In addition to the deposit, any juvenile arrested for an alcohol-related charge will be taken into custody to the Juvenile Detention Center. The juvenile will be released to a responsible adult only after the parents are notified. The responsible adult may be open to a curfew or procuring charge. Curfew in Ashwaubenon for those under 17 years of age is 11:00 p.m. to 5:00 a.m. seven days a week. All juvenile alcohol-related offenses have mandatory court dates, regardless of the distance the juvenile may need to travel. A parent or legal guardian is required to accompany the juvenile to court. Officers have the discretion to take a juvenile into custody for any offense if the juvenile is not in parental control. Officers also have the discretion to make any offense a mandatory appearance in court for both adults and juveniles.

We hope that these guidelines will help athletes, students, coaches, family, and fans enjoy their stay in Ashwaubenon.

- **Gain an Understanding and Appreciation for the Rules of the Contest**  
Being well informed is essential. Know the rules. If you are not knowledgeable about the rules, refrain from expressing opinions on decisions made by officials, coaches, and administrators.
- **Exercise Representative Behavior at All Times**  
The true value of interscholastic competition relies upon everyone exhibiting behavior which is representative of a sound value base. Your behavior influences others whether you are aware of it or not.
- **Exhibit Respect for the Officials**  
The officials of any contest are trained, impartial arbitrators who perform to the best of their ability. Mistakes by all those involved are a part of every contest. We should not rationalize our own poor or unsuccessful behavior by placing responsibility on an official. A rule of good sportsmanship is to accept and abide by the decision made.
- **Openly Display Respect for the Opponent at All Times**  
Opponents are guests and should be treated cordially, provided with the best accommodations, and accorded tolerance at all times. Be a positive representative of your school, team, or family.
- **Display Pride in Your Actions at Every Opportunity**  
Never allow your ego to interfere with good judgment and your responsibility as a school representative. Regardless of whether you are an adult, student, player, coach, or official this value is paramount since it suggests that you care about yourself and how others perceive you.
