




Who did we hear from?










Q8: Are you aware...

...the State of Wisconsin reimburses MP School District annually for an average of 18% of the operating budget from the previous year, including debt payments on construction projects?








Build a new elementary school near HS/MS – \$18M



Build a new elementary connected to HS/MS – \$18.2M












Tax Tolerance


Q13: If a tax increase is necessary to pay for facility capital improvement, what increase would you support per month based on the average home value of \$149,000?



Tax tolerance percentage breakdown: Start to combine totals to get to 50%+



Additional Considerations

- Culture based on community feedback
- Reinvestment in school system—continue striving to be a top school in the state
- Solution will provide a 50 year solution—both structurally and functionally
- Fiscally responsible solution

The committee recommends renovation and expansion of the existing elementary school to meet the building code, maintenance, ADA, parking, safety and capacity needs at an estimated cost of \$12.3M.
